Terms & Conditions

Zero siting & connection fees

Brand new caravan sales are normally charged £1000 extra to cover delivery siting & connection fees. All brand new caravans purchased in 2011 will have this included in the price you pay. Applicable to new sales made between 31/5/11 and 31/12/11.

Free 2011 site fees, electrical or garden pack

Available on selected holiday homes. Site fees from date of purchase to 30/9/11 will be included in the price you pay, you will not be charged extra for this.

Electrical pack includes: Microwave, Toaster, Kettle and Flat Screen TV.

Garden Pack includes: Patio Table & 4 Chairs, BBQ Set & Patio Heater.

Applicable to selected homes only purchased between 31/5/11 & 31/12/11.

2012 site fees held at 2011 prices

Standard site fees payable for the period 1/10/10 to 30/9/11 will be held at the same price for the period 1/10/11 to 30/9/12.

Prize draw for 5 years free site fees

All brand new caravans and park owned used caravans purchased from us & paid for in full between 4/1/11 & 29/10/11 will be issued with a raffle ticket. The raffle will be drawn on the evening of 29/10/11 during the owners Halloween party. The winner will be entitled to free site fees for 5 years commencing 1/10/11. Any fees already paid in respect of this period will be refunded in full within 14 days of the draw taking place. This entitlement is valid only whilst the caravan is owned by the original purchaser and remains on Whitehouse Leisure Park. Should the licence agreement be terminated or the caravan removed for any reason, whether this be at the request of the caravan owner or park owner, no monies shall be due to the caravan owner in respect of any unexpired period under the free site fee entitlement.
